4) Neighbourhood Planning - Update by Peter Dye

Peter Dye gave a detailed and comprehensive account of the results of the Neighbourhood Planning activity to date, with the proviso that a meeting the night before, 16 October, had changed some of the report content. These changes he did not cover. He will produce a report of his account to appended to these minutes.

BE invited comments. SD wondered if the monitoring role, whereby it was ensured that NPF planning policies as written were being applied properly, could be discussed later. BE pointed out that a decision was needed by the end of February 2019, so whether the SP Society took on this role should be a main topic for the next Committee meeting.

ACTION 1/171018 BE

It was noted that a Parish Council, with elected members, had a democratic right to hold local planning authorities to account. BE asked if anyone felt anything in the Neighbourhood process could have been improved. SD replied that some of the original questions had been 'flawed', but the process had moved on from this. PD said the majority of the village had seen the limited public documentation but might need extra explanation to enable them to express their views fully, so a six week consultation phase was quite short. He wondered whether monitoring might be more appropriate for those who devised the policies rather than the SP Society. BE thanked him for his thorough brief to the committee, and he then left.

5) Works to the pond

BE said that the grant for the works needed to be spent by the end of the financial year. It was thought that AH was happy to be involved in the process and that JC had already had talks with Dave Emery. The list of possible work included tree pruning; drainage and wall repair; a bench; notice board; reed control; supporting the pond banks. HD believed that the trees and the banks were the priority, as possibly the drainage could be done locally.
