PLANNING

Camping at Northdown Farm is now advertised on the internet and looks set to go ahead under the 28 days permitted development law. This means that the land-owner can carry out an activity for 28 days which would normally require planning permission without making an application. So at the moment this is a case of "no" planning. The Committee is consulting with our local councillors and the West Dorset District councillor for Osmington to see what actions are open to us. There is a possibility under the law of removing the 28 days permitted development -- known as an Article 4 direction. We are currently looking into this.

The Society led objections to the application for a year-round music and sale of alcohol licence at the proposed campsite. The Weymouth and Portland Council Licensing Committee came to a very balanced decision in that they refused the music licence totally and only allowed the sale of alcohol for 30 days. Your committee carefully considered this decision and came to the conclusion that it represented the optimum outcome for the village. Appealing against the decision would have offered the applicant the opportunity to run his case again (at no cost to himself) in a forum which would not have been subject to the pressure of local public opinion and could very well have come up with a decision less favourable to the village. So no appeal was lodged.

It would be very helpful if those villagers that walk the footpaths would remain vigilant in the area of the proposed campsite and report any activity which may not be agricultural to the local authority and to one of the society committee members, preferably with photographic evidence.
