#### **Your Society AGM**

Chairman Mike Blee welcomed everyone to a packed Mission Hall, and presented his Chairman's Annual Report. He thanked the three retiring Committee members, Jacqui Atkinson, Chris Balfe and especially John Sutherland for his 16 years on the Committee - ten as Secretary, three as Treasurer with significant involvement in the purchase of the "Top of the Pond" land. John then gave his last Treasurer's Report. The major expenditure was for the Society's insurance policy. A major donation went to the British Heart Foundation in thanks for their funding of the village defibrillator. With a surplus of £700, Society funds were healthy at £5155, and he recommended an unchanged subscription of £2 per person, duly carried. Bill Egerton reported on the formal relationship between the Society and Sutton Poyntz Ltd. The Company had no expenditure in its own right as the Society covered costs. Peter Dye outlined the activities of the Neighbourhood Planning Steering Group, chaired by Katrina Blee. Of the £2200 available funding, £1667 had been spent, mainly on the appointment of a Consultant, the issue of two Newsletters and a consultation questionnaire. A policy was due for issue at year end, with formal consultation to follow. The work is essentially concerned with planning issues, but also provides an opportunity to shape the village in terms of social development and facilities. There was lengthy debate on the question of Parish Council status for the village. Mike explained that although highly speculative, local government changes in Dorset could create an opportunity for Sutton Poyntz to become a Civil Parish. The AGM needed to consider whether negotiations should start with W&PBC. Cllrs Tony Ferrari and lan Bruce warned of possible complications and disadvantages and urged caution. Weymouth provides services and has significant capital assets that that the 'Parish' would have to generate for itself. Given the lack of clarity it was felt that a meeting with speakers to give different viewpoints, would be very helpful. The motion was approved: "That the Committee be given the authority to explore with W&PBC the implications of Sutton Poyntz becoming a Parish Council". (See Below) Under the Localism Act, communities are able to nominate buildings or other property for registration as **Assets of Community Value**. In the event of the sale of such an asset, the community has the right to make its own bid. Possible assets were considered during the debate. The motion was approved: "That the Committee should produce a list of potential Community Assets, with cases explaining why each asset should be registered, for consultation with the village". Peter Dye dealt with a proposed modification to the **Society Planning Policy** to include recognition of the need for suitable business and employment within the village which was formally adopted. A complete list of all **elected Committee members** follows at the end of the Newsletter. After the meeting there were refreshments and a film of Sutton Poyntz in the 1950/1960s taken by Ron Waite, then the Springhead publican.

### Which Way Forward For Sutton Poyntz? - You decide

There will be a public open meeting at the Mission Hall on Saturday 24 June at 2.30pm to discuss whether Sutton Povntz should apply for Parish Council status. W&PBC are currently holding a consultation period as they move towards becoming a Town Council under the unitary authority plans for Dorset, and as a result there is an opportunity for Sutton Poyntz to consider how it would like to be managed in the future. There will be three speakers. John Parker, Chairman, and Hilary Trevorah, Chief Executive, of the Dorset Association of Town and Parish Councils (John is also a Councillor at West Stour) and Councillor Ian Bruce of Weymouth & Portland Borough Council. They will describe what a parish council does, the implications of setting one up, answer questions on possible outcomes and explain how to go about the process. There will be a public indicative vote at the end of the meeting to consider this matter so it is really important that as many people as possible attend to help reach a decision. Anyone living and/or working in the village is eligible to vote, with the same electorate as that established for the Neighbourhood Plan. This is a neighbourhood forum event organised by The Sutton Poyntz Society. Light refreshments will be provided.
