
MINUTES of the ANNUAL GENERAL MEETING held on
Tuesday 20 April 1982 in the Mission Hall, at 7 p.m.
Mr. L. Ingham in the chair. 32 members present.

Minutes: of A.G.M. held on 24 April 1981 read and approved.

Chairman's report: Mr Ingham's report for the year ended
30.4.82 had been distributed throughout the village as
Newsletter no. 27. It was accepted with acclamation and
thanks.

Treasurer's report: Copies of Mr Saunders' statement were
circulated. He said the Society was in a better financial
situation than last year; cash in hand and at bank
was £98.21 and investments in the Halifax Building Society

were £258.05. Receipts in the year were £287.48 and expenditure £231.79. The accounts had been ~~also~~ audited by Mr Cole.

The accounts were approved, and a hearty vote of thanks was accorded Mr Saunders for his services as Treasurer over many years; he wished now to relinquish the office.

Membership of Committee. The Chairman, Vice-Chairman (Mrs Loveland), Mrs Dodge and Mrs Robinson had indicated that they desired not to seek re-election. The meeting expressed grateful thanks for their services, especially thanking Mr Ingham and Mrs Loveland.

Nominations had been received as follows:

On the motion of Mr Litschi, duly seconded, it was agreed that these form the Committee for 1982/3.

It was also agreed (moved by Mrs Litschi, seconded by Mr Mercer) that the officers be elected at the first meeting of the Committee.

Other business.

(1) Mr Litschi said the Historical Society of Gt. Britain were touring his part of the country in Spring 1983 and

- were expected to spend two or three hours in the village. It was agreed that we should entertain that Society to coffee or tea as appropriate.
- (ii) As regards the Society's representations about Sutton Road, Mrs Litschli said that the Borough Council had provisionally set this work down for the year 1986/7.
- (iii) On Puddledock Lane and Sunnyfields, Mr Litschli said that Dorset CC. had plans for the making up of sections of Beam Acres and Lone Lane during 1983/4.
- (iv) Mrs Presely and Mrs Brown were hoping to arrange a garden tea-party at the end of June.

The meeting closed at 7.40 pm. Afterwards Mr K. Bartlett of Devonish Ltd gave a most interesting and informative talk on the history of wine, for which he was thanked very much. He provided a glass of wine to everyone present.
