- 2. The minutes of the meeting of 4 April were read and approved.

# 3. Matters arising

- a. Village Green. No further response has been received from Mr Strong of Bradens (nor Mr Seal). It was proposed that we should write again referring to our previous letter and also identify the potential availability of funding.

- e. Periodic Electoral Review. After some discussion, no action was deemed required for this routine review of the electoral boundaries.
- f. Traffic conditions in Sutton Road. After some discussion it was decided that this matter should be reviewed following completion of the new houses.
- g. Cars parked in Plaisters Lane etc from the Cart shed. JL has had discussion with Tony who has understandings with various local residents regarding parking outside their houses he now only has 4 cars having recently disposed of 3 vehicles. He has been practising defensive parking: in Old Bincombe to minimise damage to the verges from reversing vehicles parking outside the Cart shed in winter nights to reduce the likelihood of break-ins also parking outside the Cart shed during the day to slow traffic down at the corner, which he believes is a hazard. Following some discussion, it was agreed that there is the need for a compromise if we wanted an "active, lived in community". It was also pointed out that all non residents cars tend to be blamed on Tony, although many could well be visitors. The situation was concluded as acceptable but should be monitored over the next 12 months.
