- 2. The minutes of the meeting of 12 February 2002 were read and approved.

3. Matters arising

- a. $\ensuremath{\mathrm{JL}}$ noted that the area by the Village stone had been greatly improved by SE and his team.
- b JA (and TB) advised that the WPBC had not forgotten the pond cleaning but there was no revised date at present.
- c. Thanks were expressed to DE and his team for their work in turfing the orchard area.
