# Minutes of the meeting of the SPS Committee held on Tuesday 22 October 02 at 99 Sutton Road Joyce Litschi in the chair

- 1. Apologies Simon Emblen, David Emery, Liz Randall
- 2. The minutes of the meeting of 3 September 2002 were read and approved.

## 3. Matters arising

- a. Pond cleaning by W&PBC JA to contact the W&PBC continues.
- b. JS has not written to W&PBC re the condition and rats seen around 111 Sutton Road. It was noted that the house is currently up for sale and a letter would now be inappropriate.
- c. The plaque required for the millennium trees. JS has spoken to Alan Jolliffe re the offer to supply a large stone on which to mount a single plaque. He will deliver it when he next has suitable equipment JS to remind him from time to time.
- JS to write to WW for their agreement on siting the stone on the path side of the fence adjacent to the first tree perhaps laying down and usable as a seat.
- d. JS to contact Susie Wynn Williams re filling a vacancy on the committee at the next AGM.
- e. It was suggested that the committee should add the plaque to the millennium stone noting that was erected at the millennium by Mr Jolliffe and also include the date erected.

#### 8. AOB

- a. JA related an incident whereby she was nearly knocked down by a car in Plaisters Lane which was only avoided by her leaping out of the way and in so doing injuring herself on rebounding from the bank onto the roadway. - b. It was noted that the tree felling / pruning at the edge of the waterworks appears to have satisfied all interested parties.
- c. JL advised that she had been requested to get the W&PBC to lower the "No through road" sign at the end of Sutton Road to attempt to dissuade drivers from trying to drive through White Horse Lane. It was suggested that the individuals involved should approach the council first themselves.
- d. A comment that the willows around the pond were getting overgrown has been received. JA to ask advice from W&PBC re their maintenance intentions when talking to them re dredging the pond.
- e. JS noted that brambles growing from the hedge between the Saunders field and Plaisters lane had been causing difficulty to pedestrians. Elizabeth Saunders was to talk to the Lunns who cut the hedge meanwhile she (with Dereck and JS) removed the offending brambles which were the cause of the pedestrian (cyclist etc) danger.
- f. JS advised that N Brown had advised that MH AGM is planned for 30 October.
- g. Next newsletter due out in November. SPS AGM planned for 10 April. It was suggested that we should ask Richard Backwell if he would give a talk on his current (recent) trips at the AGM.
- h. JA noted that the Springhead changes hands around the 10th Nov.
