- a. Action Continues -re JS to remind Alan Jolliffe re supply and siting of large stone on which to mount a single plaque for the millennium trees. He has promised to deliver and erect it when he next has suitable equipment. JS has spoken to Les Jolliffe who ws not aware but is now and is still willing. Noting the activities of WW at present in the area.
- b. Action continues re We will purchase a seat with the donation received from WW to be sited along the road side of the hall. JA to action.
- c. It was noted that the green wedge has now been improved with a gravelled area in front of the stables!
- d. SE noted that Mr Strong has indicated that Mr Seal will re grade Puddledock Lane (not tarmac). He was also aware of the dead elm trees that will need removing.
