- b. Action continues re We will purchase a seat with the donation received from WW to be sited along the road side of the hall. JA to action in the Spring. JA noted that one of the neighbours has some surplus paving stones, which could be used at the hall - JA to advise neighbour and DE.
- c. It was noted that there was some concern on activity in the green wedge at Puddledock with diggers arriving etc; no positive moves observed however.
- d. It was noted that there have been moves re re-grading Puddledock Lane and removing the dead elm trees although the initial work seems to have halted. There is some opposition to the proposed fencing on the roadside of the ditch. See letter in correspondence from Mr Strong.

The Environmental Partnership: Meet on 24th Feb

Community Group: Given an update on the plans for a study on wind energy feasibility off Portland Harbour. No planning permission is required; Council is acting as a consultant to Powergen. It has been proposed that waste management will be providing wheelie bins (2 off) as well as existing green boxes. Green box collection to be extended from 31st Mar to include light card (eg cereal boxes). Local Plan inquiry delayed by a month to start on 2nd Mar (see also correspondence). Local plan inquiry will not debate the need for the new road - inquiry will start from the assumption that the orange route will be implemented.

Victorian Fayre committee: meeting 12th Jan. Christina Anderson has been in contact with food providers.
