3. Matters arising

- a. Action Continues -re JS to remind Alan or Les Jolliffe re supply and siting of large stone(s) on which to mount a single plaque for the millennium trees. He has promised to deliver and erect it when he next has suitable equipment. (Post meeting note JS has given copy of letter to WW to AJ which indicates the position for the stones.)
- b. DE to pursue WW and W&PBC re pond de-silting DE advises that it appears that W&PBC will not be driving the work (Robert George)– previous work on the pond was done by the Parks department as a goodwill gesture they apparently have no statutory responsibility for the pond. DE has obtained Land Drainage Application Form from the Environment Agency to move the process forward with the SPS leading. Legal responsibilities are not clear noting that WW will be placing any contract to complete the works. DE keeping DWT, WW and W&PBC fully informed. c. The telephone box by the cart shed is now reinstated.
- d. Further to request to lower the speed of cars traversing Sutton Road, JL requested that we ask W&PBC to install a 20MPH speed limit along the road. Action agreed.
- e. No further action has been taken regarding planning permission for the Buckleys conservatory.it was decided by the Chairman and DE to let the matter drop at present.

5. Planning Matters

- a. He did suggest that there might be money available to undertake tasks such as replacing the elms in Puddledock. Planning group to meet re expanding the Village Plan identifying areas of the village or views within the village that are considered essential for conservation.
- b. It was noted that there are rumours of the developer of the Mission Hall Lane site were looking for additional land to expand the current approval. It is understood that the view of CPRE is that West Dorset District Council appear to be more critical in reviewing planning applications than W&PBC.
- c. Springhead signs refusal no evidence of any movement re implementation.

- f. It was noted that the planning application for 17 Fisherbridge appears to have been mis-located it appears to be in a different part of Preston Road to that suggested in the planning application notification.
