- i. JS reported that the council trees officer (Rick Slatter) had no indication of replacement trees for the area of Puddledock recently cleared of dead elms. He indicated that the roots would soon shoot again and grow into trees over the next 15 20 years and then get hit again by disease. TB suggested that willows would be an attractive addition to area and they appear to grow easily from off cuts. It was suggested that some could be dropped in the area when suitable off cuts are available.
