- 2. The minutes of the meeting of 24th April were approved and signed.
- 3. Matters arising none.

4. Committee Sub groups

The Mission Hall trust – SE reported that there is now a doorway between the new extension and the hall. Old cupboards had been disposed of and all kitchen materials moved to the extension. A pathway outside has been completed and some further work is required to improve access to the garden. A retaining wall has been completed.

The Environmental Partnership – next meeting is 21st June to be hosted at the Mission Hall. A conference with 6 workshops is planned for 30 June at Weymouth College. The Community Group – no meeting.

5. Victorian Fayre

Society Tombola stall – SE advised that he has received 64 prizes so far. He needed assistance to approach businesses – PJ took the list for Dorchester, TH the list for Weymouth and PR the local list. SE to provide letter of authority ASAP. Thu 22 Jun at 10.30 at Wyndings for labelling etc. All would be welcome. The large drum was previously obtained by Don Brierley – SE to chase. 6. Conservation and Environment Working Group Report

- a. Stiles, Trees around the Pond, BOATs no change.
- b. TH noted that the demolished road sign at the end of Plaisters Lane has been reinstalled not known by whom.
- c. Village Plan. TH advised that some 72% returns of the questionnaires has been obtained with variation around the areas from 40+% in Verlands/Winslow to 90% in Plaisters. Comments have varied from the negative to the very supportive. Analysis is the next phase.

It was noted that there were articles in the Echo and the Register.

The stand at the Fayre on 25th June is expected to be located on the village green alongside the info tent. Proposed to publicise the Society and recruit new members if appropriate.

Also a demand that any work should ensure that all materials are stored on site and any local residents are not inconvenience is minimised.
