5. Conservation and Environment Working Group Report

<u>Village Plan</u> - TH reported that the steering group met on 10^{th} Jan. The input of survey data has been completed and is being analysed by DCA to reveal the underlying stats. More work is involved in this operation than estimated and a further cost (up to around £500) is likely to be involved. The public meeting for reporting has been arranged for 29^{th} March from 7-9 p.m. at the Waterworks museum. An early completion to the report is aimed to provide input to the Community Plan review.

For publicity, an article is being submitted for publishing in The Register and Chris Hubbard is being informed.

<u>Conservation</u> – TH has drafted a letter to Mr Hunt summarising the position with the third stile and acting as a go-between with DCC. TH has noted that the stile behind Southridge is also in a poor state of repair.

It was noted that some dog walkers continue to ignore good stewardship of both their dogs and the environment. We need to provide good examples and remain diligent.

Willows around the pond - ongoing.

TH has quote for display case for banner of £149 from Cacklebury Frames. Agreed to purchase. Note to be added in case to show donor and needlewoman.
