- 2. The minutes of the meeting of 3rd September were approved and signed.
- 3. Matters arising: -
 - Continuing:
 - No comments on progress with contacting Mark Fernyhaugh or the new owners re. plaque that had fallen from the Old Court House. It was suggested that this be placed lower than before with the lettering painted in to make it easier to read. TB to pursue.
 - Re additional dog bins. Ray Aggett had been talking to a Laura Harman who had suggested

 been told by her boss (Carl Dallison) that W&PBC will be withdrawing the emptying of dog
 hins
 - As it was understood that the original planning conditions for the "farm labourers cottage" were that this property should only be occupied by someone working on the land, it was suggested that we should write to the planning department to ascertain the position. (Voted 9 for, 2 against.) outstanding.

 were to write to DCC (Tim Westwood) re suitable signs and better siting also a request to
 apply pressure to persuade Sat Nav systems providers to use appropriate roads for heavy
 vehicles. Understood a heavy vehicle en route to Goulds garden centre got stuck last week.

 - New collector and distributor for Newsletters wanted to replace TH. Suggested, possibly add to Newsletter to ask for volunteer.

5. Conservation and Environment Working Group Report

Conservation - No actions.

<u>Village Plan (VP)</u> - PJ reported that the Village Plan document is at the printers – expected printed by early November. Copies allocated to our 3 local councillors.

 - "Objection" sent re felling Oak tree at Smithy Cottage (seems unnecessary), demolish Cart shed (suitable refurbishment desirable), building pair of semis replacing the Cartshed
 - "Comments" submitted re 1 Myrtle Cottage (windows in extension seem excessive)
 - New applications to be reviewed. Meadow View new garage (07/759).
 Waterside caravans replacing existing touring area with 45 static caravans (07/00729/COU) concern expressed with any expansion of caravan sites (2000 already in Preston). Similar approach to Bourne leisure noting that easier landscaping potential as sited under the adjacent hill. Objection to be raised similar to recent Bourne Leisure case. Noted that all caravan parks are outside the development area.

Cream Teas - Concern was expressed on the waste of some £62 of members funds following abandonment of cream teas. Some materials used for a MacMillan Coffee morning that raised £491.51. Thank you note received (but no reimbursement).
