- The meeting only discussed key items due to other commitments of the Secretary and the absence of the Chairman. In the absence of JC the chair was taken by JB. The minutes of the meeting of 18th June 09 were approved and signed.

3. Matters arising: -

- Not discussed Continuing from previous meetings "There was some debate of what action the committee could
 take to follow up the planning refusal of the implement store at the Green Gap. JC trying to get response from
 planning asking if there was any change in the situation." was overtaken by application for Donkey food store now relevant again.
- PR has placed the DVD of the Video provided by TB in the Mission Hall for anyone to borrow. Currently still
 missing presumed borrowed. GE asked if he could liaise with the MHT to ensure that it has not gone permanently
 missing; if not recovered to be mentioned the next Newsletter (Aug).

. Planning Matters

Applications

09/146 Fuschia cottage, addition detached house – Going to appeal. Objection letter written. Addition letter requested by committee to enquire if the committee might speak to the Inspector at their site visit.

09/231 Springside fell Monterey Pine and Aspen – withdrawn and replaced with 09/364 to reshape Monterey Pine; commented willing to accept trees officer view.

09/361 Laurel cottage – shed – permitted. (Decision Notice - The hedge and shrubs to the west and the south of the shed shall be retained and where necessary reinforced with other appropriate planting, these to be submitted to and agreed in writing with the Local Planning Authority.

Reason: In order to provide continuing adequate screening to the shed and therefore retain the character of the Conservation Area and the setting of the Listed Building in accordance with Policies B1, B8, B10 and D3 of the adopted Weymouth and Portland Local Plan 2005.

9/294 Peveril Garage and porch -circulated note agreed sent; approved by W&PBC.

09/381 Fuschia cottage, Tree works. Details not yet on-line (19July) but viewed by MT. It appears that the pittosporum involved is in the adjacent property. Following vigorous debate it was decided that an additional comment be sent expressing further concern to supplement previous comment – ("We are willing to accept the opinion of the trees officer who will be in a better position to advise in this case; however, we note that this area is subject to a planning appeal to which trees and hedgerows are relevant.")

09/342 Comms antenna and mast etc at Chalbury reservoir - comment sent as circulated. (We realise that the march of

progress needs telecoms equipment but note that the phone companies will only take as much care of the environment as they as forced to. We wonder why the new equipment cannot be mounted on the existing masts. We also wonder if it is practicable to plant trees to mask any new mast?)

- Village plan implementation Most Items not discussed in absence of JC
 - History
 - Crime prevention PJ has advised that request for funds for Homewatch administration costs has been rejected by the Safer Communities Group.
 - Conservation of village character
 - Rights of Way & Countryside Access Group producing a <u>leaflet</u> on walk(s) in progress Letter from Wessex Watermark advised that grant has been awarded. JC has acknowledged by e-mail. Date to be set for presentation of award Both Sara Knight and Roy Winstanley have been informed. Date to be left to JC to organise to suit his diary. Addition funds will be required to complete task in the order of £50 award of grant agreed by committee.
 <u>Interpretation Panel</u> Not discussed.
 - Wildlife Habitats (Biodiversity) Not discussed Copy of the Society constitution previously requested has been sent to DE.
 - Traffic Not discussed Letter re 20mph limit through village, suggested at last meeting, still required.

It was noted that the number of members in Mission Hall Lane is significantly reduced this year. Current balance is £3976.53 (including £179.70 from DWT grant fund). Copy of statement filed.

Letter to be acknowledged decision on request deferred to return of JC various option discussed were resiting duck house at alternate location (none defined) talk to Dave Caddy, Maureen Morris, Julia Allen, Elizabeth Saunders etc. Another option is to let them go wild and / or feed them on the pond side. Further discussion needed.
