Agreed, any material costs to be paid by Society and recovered from profit on the day. The committee reflected that there appeared to be some concern that the Fayre may be planning to fund some of the village activities initiated by the Society (following from the Village Plan). The conclusion was that it was felt that the perceived problem was that Fayre donation intentions were not clear.

# 7. Planning Matters

10/00114/NONMAT detached house adjacent to Fuchsia cottage. Database was unavailable. JC reports that request is to add two windows at ground level on the wall facing Fox Cottage and change an upper window on the wall facing the hills to a Juliet style window. It was noted that original application made a point of the claimed non invasion of privacy – the addition of windows to the east wall overlooking Fox Cottage appear to contradict the original case for approval. (Post mtg note) Comment sent - The Sutton Poyntz Society was opposed to the approval of this house as it did not enhance nor reinforce the Conservation Area. The Society does not object to the change in window style to a Juliet balcony, which reflects a matter of taste or design. However, a significant claim in the original application was that the siting and type of windows (frosted) would not impact on the amenity space of neighbouring properties. The addition of two clear windows at ground level on the east wall facing Fox Cottage appears to contradict part of the original case when seeking approval.

10/00095/ful, 23B Sutton Road Sutton Poyntz Weymouth Dorset DT3 6LS – 2 storey rear extension. (Post mtg note) Comment sent - The Sutton Poyntz Society requests that the planning officers ensure that materials used are compatible with the existing properties and the area. It is noted that the East side of the extension to the rear of property will be visible from Sutton Road whereas the east side of the existing house is hidden by the adjacent row of cottage style properties.

## 8. Village web site

Bill Egerton reported that he had applied for funding from the South Dorset Ridgeway Project and was awaiting a response. Planning to assemble small team to work out detail content of main pages. JC advised that Bill wanted views on the editorial control structure for the web site. JS suggested that perhaps an interested group from the SPSC (similar sub committee was used to form planning group in earlier committees) should form a management board together with Bill and any other party Bill recommended. Item referred to BE for his comments.
